AUGUST 16, 2021

Council President Mary Leatherman opened the meeting with the following members present: Judith Yahraus, F. John Betts, Richard Hupe, and Jim Kozumplik. Also attending in person were: Mayor Carrie Schlade, Fire Chief Bruce Siders, Street Commissioner Tyson Engstrom, Police Captain Greg Ruskey, Parks and Recreation Director Benjamin Dominique, and City Clerk-Treasurer Laura I. Rode.

Mr. Betts moved, Mr. Kozumplik seconded, to approve the minutes from the August 2, 2021, Regular Meeting as written. Roll call vote: all ayes; nays, none. Motion carried.

Mrs. Yahraus moved, Mr. Betts seconded, to approve the minutes from the August 9, 2021, Special Meeting as written. Roll call vote: all ayes; nays, none. Motion carried.
