

# ACTIVITY REPORT FOR JUNE 2023

#### A Letter from the Chief

Bryan Fire Department is committed to providing the best service to the community we protect. Changes in dispatching for medical first responder calls initiated at the end of May account for a fivefold increase in medical and rescue calls for the department. Bryan Fire Department is now dispatched simultaneously with Williams County EMS for medical calls in the fire district instead of delays for special request and communications between County and City dispatch centers. The faster notification speeds the response of medical care to patients.

While adequate staffing is readily available to handle the additional workload of medical calls, fire response continues to rely on automatic mutual aid from the surrounding fire departments. All fire departments in the area continue to struggle with staffing. The volunteer fire service is at a crisis level. Bryan Fire employs a number of part time and paid on call firefighters to supplement staffing. Fire training for new recruits will start in September. Anyone interested in becoming a fire fighter should contact their local fire department.

Consumer grade fireworks are legal to possess and may be legally discharged when in compliance with state laws and regulations. It is not legal to discharge consumer fireworks on public property (parks, roads, school yards, etc.). No one under the age of 18 may handle or discharge fireworks. Aerial devices, roman candles and bottle rockets require a minimum of 150 feet from buildings, combustible material and spectators including anyone under the age of 18. Non-aerial devices, fountains, and firecrackers require a minimum of 50 feet separation. Minimum distances increase up to three times around multifamily dwellings and other special occupancies. In cooperation with Bryan Police, we will continue to educate the public about the law. The safest practice is to leave fireworks to the professionals. Enjoy fireworks displays and community events. If you are planning to discharge consumer grade fireworks, follow Ohio Revised Code (R.C.) <u>3743.45</u> and Ohio Fire Code (OFC) <u>1301:7-7-56(Z)(5626)</u>. Have a safe and enjoyable summer.







#### Non-Personnel Attendance per Event Type for Date Range




