#### **December 4, 2023**

City Attorney Fishel's suggestion was that any action could wait until the December 18, 2023 meeting, which he plans to attend.

### AN ORDINANCE LIMITING ADULT USE CANNABIS OPERATORS, ADULT USE CULTIVATORS, AND ADULT USE DISPENSARIES OPERATIONS WITHIN THE CITY OF BRYAN (AS AMENDED)

was presented and read by title only.

Ms. Leatherman moved, Mrs. Yahraus seconded, to further amend Ordinance No. 57, 2023 by changing Section 3 to read, "That the growing and selling ...", by adding the words "and selling". Roll call vote: all ayes; nays, none. Motion carried.

Ordinance No. 57, 2023 was let lie after its second reading, as amended.

Resolution No. 53, 2023, titled,

A RESOLUTION AUTHORIZING THE CITY ENGINEER OF THE CITY OF BRYAN, WILLIAMS COUNTY, OHIO TO APPLY FOR THE FISCAL YEARS 2024-2025 WATER AND WASTEWATER INFRASTRUCTURE GRANT FOR THE CITY OF BRYAN AND BRYAN MUNICIPAL UTILITIES, WILLIAMS COUNTY, OHIO AS NECESSARY

was presented and read by title only. City Engineer Wieland explained that this is the same source of funding as had been used for the Horton Height Sewer Project, that here is an unusually tight window in which to apply, and that the exact project will be determined at a later date, if the funding is awarded.

Mrs. Yahraus moved, Mr. Betts seconded, to suspend the reading of Resolution No. 53, 2023, on three separate days. Roll call vote: all ayes; nays, none. Motion carried.

Ms. Leatherman moved, Mr. Kozumplik seconded, to pass Resolution No. 53, 2023. Roll call vote: all ayes; nays, none. Motion carried.

Planning and Zoning Administrator Waterston requested Council approve a building permit for a \$266,000 building renovation for Ridi Stores, LLC at 1108 S. Main Street.

Attorney John Shaffer introduced his clients, Mo and Tim from Ridi's, who spoke about their plans for a convenience store in the former Bryan Drive-Thru building, for which they will coming back to City Council at a future meeting to request a TREX liquor permit. The owners plan to have a total investment of nearly \$600,000 in the building when completed. Further discussion was held.

Mr. Kozumplik moved, Ms. Leatherman seconded, to approve a building permit for a \$266,000 building renovation for Ridi Stores, LLC at 1108 S. Main Street. Roll call vote: all ayes; nays, none. Motion carried.

Mayor Schlade thanked all who participated in the Santa Parade, and informed City Council that earlier in the day she had attended a meeting at the Ohio Governor's Mansion as part of a group discussing housing issues with Governor Mike DeWine.

Planning and Zoning Administrator Waterston provided City Council with copies of the proposed/updated Planning and Zoning Code for review. A public hearing and legislation on the new language will be included on the next City Council Meeting agenda.

All members of City Council, in turn, thanked Ridi Stores for its investment in the City of Bryan.

A brief recess was taken.

Ms. Leatherman moved, Mr. Kozumplik seconded, to go into Executive Session to discuss the appointment and compensation of a public employee at 5:53 p.m. Roll call vote: all ayes; nays, none. Motion carried.
