### **BRYAN CITY COUNCIL**

#### July 15, 2024

Council President Mary Leatherman opened the meeting with the following members present: Jim Kozumplik, F. John Betts, Richard Hupe, and Stephen Alspaugh. Also attending were: Mayor Carrie Schlade, Planning & Zoning Administrator Andy Waterston, Police Chief Greg Ruskey, Fire Chief Doug Pool, Street Commissioner Tyson Engstrom, City Attorney Marc Fishel, Director of Utilities Derek Schultz, and Clerk-Treasurer John Lehner.

Mr. Kozumplik moved, Mr. Alspaugh seconded, to approve the minutes of the June 17, 2024 Regular Meeting and the June 26, 2024 Joint Special Meeting, as written. Roll call vote: all ayes; nays, none. Motion carried.

Fire Chief Pool reported that the Police Department received multiple complaints about fireworks over the weekend and Independence Day Holiday. While the City of Bryan permits use of fireworks in accordance the Ohio Revised Code, those laws are frequently not followed, and he asked that Council reconsider the topic of a total fireworks ban.

Bryan residents Mr. & Mrs. Gary Nungester addressed Council with concerns over loud music played by their neighbors and the apparent lack of a residential noise ordinance within the City. The existing law only applies to noise from vehicles. Further discussion was held.
