Ordinance No. 36, 2025, titled,

AN ORDINANCE ESTABLISHING THE SALARY SCHEDULE FOR THE BRYAN VOLUNTEER FIRE DEPARTMENT, AND REPEALING ORDINANCE NO. 23, 2022, PASSED APRIL 4, 2022

was presented and read by title only. Chief Pool explained the need to update rates to stay ahead of minimum wage adjustments, but also that the proposed rate structure goes even further in order to remain competitive with neighboring communities for part-time help.

was presented and read by title only. Clerk-Treasurer Lehner explained that the overall increase for employee health benefits in the coming plan year will be 5.0 percent, negotiated after an initial quote from Medical Mutual of Ohio of nearly 10.0 percent. As

has been past practice, the same rate increase is proposed to apply to the employee contribution toward premium.
