



BEVERAGE POLICY

FOUNTAIN CITY AMPHITHEATER

The serving of alcohol is permitted at the Fountain City Amphitheater under the following strict and specific guidelines as set forth by the City of Bryan Fountain City Amphitheater Beverage Policy. The Fountain City Amphitheater is a City-owned, public facility and therefore any party wishing to serve/sell alcohol must adhere to the following guidelines without exception. It is the Renter's responsibility to ensure that all requirements have been met through the City of Bryan Parks and Recreation Department. The City of Bryan has final jurisdiction and reserves the right to disallow the service of alcohol and/or cancel and/or stop, any event.

1. Event hosts must be 21 years of age, complete and file the Fountain City Amphitheater Facility Rental Permit and Alcohol Request Form along with a copy of any state/local alcohol permits and required Liability and Alcohol Insurance certificate approximately 45 days before event date.
2. Possession and consumption of alcoholic beverages must be restricted to a designated alcohol section (map provided by the City) of the grounds cordoned off with fencing and/or double lines of rope.
3. Any person wishing to consume alcohol must be 21 years of age at the time of the event, event host or an event volunteer must card every individual prior to entering designated alcohol section and must provide a wrist bracelet indicating they are at least 21 years. No one under 21 years of age shall be permitted in the designated alcohol section of the grounds. No alcohol may leave the designated area.
4. Only those who are 21 years of age may serve alcohol, and no volunteers should consume alcohol while working their shifts or before their shifts. It may be necessary to have those that are dealing with money or distributing wristbands not to consume alcohol at anytime prior to or during working shifts.
5. The City of Bryan requires all events that will be serving alcohol to hire at least one (1) off duty City of Bryan Police Officers. These officers are to be paid for by the renter. You should contact the City of Bryan Police Chief to arrange for this service prior to submitting an alcohol request form.
6. No "bring your own beverage" or brown bagging" is allowed.
7. Glass containers are NOT permitted.
8. All alcohol trash must be cleaned up and removed from City property during clean up.
9. The permit holder must have a copy of all permits with them on site and available for law enforcement or Parks and Recreation staff viewing.
10. Alcoholic beverage service may begin 30 minutes prior to schedule event and must be discontinued at least 30 minutes prior to the scheduled end time of the event. NO person shall be in possession of an alcoholic beverage at the conclusion of the event or outside the specified drinking section.
11. At any time, the City of Bryan Parks and Recreation Staff and/or City of Bryan Police Department may revoke this permit for any reason deemed necessary.

It is the responsibility of the event hosts to fulfill the above guidelines including those required by the State of Ohio. If any guidelines are not met before, during or after the event, renters will be held accountable to the fullest extent of the Fountain City Amphitheater Facility Rental Agreement, City of Bryan Municipal Code, and the Ohio Revised Code.
